**Governance and Regulations.** Duluth Township has an elected 5-member Town Board, an appointed Treasurer and Official Town Clerk, a part time Police Department and a Volunteer Fire/EMS Department. We have our own Comprehensive Plan, Zone Map and Zoning Ordinance. For these and an explanation of Township governance see the Township web site or Town Hall.

**Local Jurisdictions:** Our Town Board of Supervisors is the primary local governing body. Duluth Township is also represented on the North Shore Management Board dealing with broader issues along the shore to Canada. The Duluth/North Shore Sanitary District (D/NSSD) manages the sewer line along the shore. Lake Superior School District #381 is the school taxing district that includes Duluth Township. Our K-6 grade North Shore Community School (NSCS) is a charter school in a district of its own but without taxing authority. Duluth Township is in: US Congressional District **8**; State Senate District **03**; State House District **03B**; County Commissioner District **5**; County Soil and Water District—**South**
