

Town of Duluth Ordinance List

1. Dance Hall Ordinance 1/8/1975
An ordinance regulating the establishment and operation of public dance halls and places where public dancing may be held in the Town of Duluth, St. Louis County Minnesota.

2. Disposal of Solid Waste Ordinance 1/8/1975
An ordinance providing for the disposal of Garbage and refuse in the Town of Duluth, St. Louis County Minnesota.

3. Parking Ordinance
An ordinance for regulation of overnight parking on public and private land between scenic highway 61 and the shoreline of Lake Superior in the Town of Duluth.

4. Annexation Ordinance 4/9/1992
An ordinance setting the policy of the Town of Duluth, Minnesota concerning the review of petitions for annexation.

5. Land Application of Petroleum Contaminated Soil Ordinance 12/10/1992
An ordinance providing procedures for an restrictions upon the practice of land application of petroleum contaminated soil within the Town of Duluth.

6. Utilities Ordinance 8/13/1992
An ordinance regarding notice from utilities to Township prior to conducting operations in Town Road right of way.

7. Fertilizer Ordinance 8/13/1992
An ordinance prohibiting the use of certain substances as fertilizer within the Town of Duluth, imposing conditions upon the importation for use of other substances as fertilizer within the Town of Duluth, and imposing penalties for failure to comply with the ordinance.

8. Zoning Ordinance Number 3 8/12/2005
Zoning Ordinance for the Town of Duluth, Minnesota, otherwise known as Ordinance Number 3. The intent of this Ordinance is to establish comprehensive land use regulations for the Town of Duluth in accordance with the provisions of Minnesota Statutes Chapters 366 and 462 and all acts amendatory thereto or other legislative changes hereafter enacted. The purpose of this ordinance is to promote the health, safety, and general welfare of the community by dividing the Township into zones and regulating the uses of land and the placement of all structures. This ordinance seeks to encourage the most appropriate uses of land in the Township, to encourage and maintain the community as rural and in balance with its many natural amenities, to protect its rich and diverse natural resources for future generations, and to provide a basis for a sustainable community.

9. 011196 Barking Dog Ordinance 1/11/1996
It is the intent of this ordinance to provide a procedure by which complaints of habitually barking dogs can be brought to the Town's attention, by which a determination can be made of whether the dogs are or are not a nuisance, and to provide a system of fines and penalties for owners who harbor dogs that have become a nuisance by habitual barking.

10. 101096 Responsibilities and Prohibitions against Owners of Animals 10/10/1996
 For a number of years the Town of Duluth has had an ordinance regulating the keeping of animals in the Greenwood Beach platted area. That ordinance, among other things, allows the Town's Peace Officers to deal with animals that run at large, threaten property, or threaten persons in the platted area of Greenwood Beach, places some restrictions on the keeping of animals there, and provides fines for violations.
 The Town has never had an ordinance regulating animals outside of the Greenwood beach platted area. The Town has always believed that it does not have the financial resources or personnel to enforce animal control regulations in the township outside Greenwood Beach.
 Greenwood Beach are becoming more and more common. The Town wants to be of some aid to its citizens in dealing with those problems, but has financial and personnel limitations that prevent it from extending the types of regulations present in Greenwood Beach to the township at a whole. The Town also wants a uniform ordinance throughout the township rather than separate ordinances for Greenwood
11. 111496 Junk Car Ordinance 5/1/1997
 Excessive amounts of junk motor vehicles and junk property in open view constitute a hazard to the health and welfare of the people of the Town of Duluth in that such junk can harbor and attract vermin and present physical dangers to the safety and well-being of children and other citizens. Excessive amounts of junk motor vehicles and junk property in open view are a blight on the landscape, adversely affect the environment, and adversely affect property values of nearly neighbors and of the township as a whole.
12. Lundquist Road Alteration Ordinance 5/5/1976
 This ordinance may be known and may be cited as the Town of Duluth Lundquist Road Alteration Ordinance. The Town Board of Supervisors of the Town of Duluth hereby alters and widens to a minimum of 100 feet the Lundquist Road.

1. Utility Ordinance # 81392 8/13/1992
 Ordinance regarding notice from utilities to Township prior to conducting operations in Town Road right of way.
2. Contaminated Soil Ordinance # 121092 12/10/1992
 An Ordinance providing procedures for and restrictions upon the practice of land application of petroleum contaminated soil within the Town of Duluth.
3. Animal Control Ordinance #21 1994
 Certain areas within the Township of Duluth are inhabited by many dogs, some of which are allowed to run at large endangering the health and safety of residents and properties of the Township.

4. Adult Use - Sexually Oriented Business Ordinance # 71306 7/13/2009
Purpose is to regulate all Sexually Oriented Businesses as identified herein in order to protect the health, safety and general welfare and property values of the citizens of Duluth township through reasonable and uniform regulation of said businesses throughout the Township.
5. Amendments to Zoning Ordinance #3 8/12/2005 adopted 8/10/2007 8/10/2007
The Board of Supervisors of the Town of Duluth ordains that the Town of Duluth Zoning Ordinance Number 3 - August 12, 2005 (the ordinance) be amended as described in this document.
6. Interim Ordinance # 51100 Conditional Use Moratorium 5/11/2000
The granting of conditional use permits in the W2, LSO, and commercial zone within the portion of the town that is within the boundaries of the Duluth-North Shore Sanitary Sewer District is prohibited for a period of one year from the effective date of this interim ordinance.
7. Interim Ordinance # 6905-2. Sexually Oriented Moratorium 6/9/2005
That a moratorium is in effect and that no sexually oriented business will be allowed or permitted within the Township until the special planning process has been completed and the Town Board has taken final action upon the same or, if said moratorium is not validly extended.
8. Interim Ordinance # 09408 Short Term Rental Moratorium 9/4/2008
The purpose of this moratorium is to allow time for the Planning and Zoning commission to study the appropriateness, the desirability and effects of short term rentals, and to recommend to the Board what modifications to the Zoning Ordinance would be appropriate to better manage this land use in the Township.
9. Ordinance # 050808 Regulating Surface Water Run-Off 5/8/2008
Purpose is to enact reasonable regulations to prevent interference with the construction, maintenance, and safe use of town roads within Duluth Township.
