The Alger Line — Part 3 of 4

By the year 1915 the Duluth & Northern Minnesota Railway had become a strong little railroad with operations in all three of the counties that make up the arrowhead region. Its mainline now extended 100 miles from its terminus at Knife River all the way into central Cook County. A major branch line ran through Duluth Township and nearly back to Lester Park. Other branches led to the base of Molde tower hill and Alden Lake on the Cloquet River. Farther up the mainline numerous branches and spurs radiated into the virgin timber tracts. Possibly between 400 and 500 miles of branches and spurs snaked their way through the timberlands. There were stories of connecting to the Port Arthur Duluth & Western Railroad at Gunflint Lake and gaining access to the Canadian port on Thunder Bay. Rumors circulated that Alger - Smith was going to build a giant sawmill at Knife River, which would again be the largest in the world.

These were exciting times in 1915 and the future looked very promising. In reality, it was becoming very expensive to ship the logs 100 miles and then pay the Duluth & Iron Range Railway to haul them 20 more miles from Knife River to Endion. There they had to be transferred to the Northern Pacific to be taken to one of the two sawmills, again for a fee. Fuel for the 13 locomotives, track maintenance, wages for all of the train crews, logger's wages, and other overhead began to erode profits. Worse yet the timber in Cook County was of poor quality. There were more lakes to load logs from during the summer in Cook County, but the terrain was hilly and rocky making spur building difficult and expensive. Yet in spite of these many persistent drawbacks, General Manager John Millen still believed his railroad would overcome these hardships and prevail for decades into the future. He had been with the Alger Smith Lumber Company since before their first logging railroad was built back in 1868. John Millen was the heartbeat of the Alger Line and when he died suddenly at 2:00 P.M. July 22, 1916, the railroad began to die as well.



Steam engine 261 visited Duluth in early June on a historic tour. The engine was built in 1944. An early schedule included stops at the former Palmers Station (by Homestead Road) and Two Harbors but those plans were dropped. Here #261 is in the Duluth rail yard near the train museum.

Senior Housing Initiative

The Senior Housing group conducted a study to determine how many seniors moved from their home in the Township to housing elsewhere over the past 10 years, the apparent reason for the move, and the type of facility they moved to. The study was able to estimate the likely interest in senior housing in our area. The study was paid for by a small grant from the Town Planning Commission. A group of long-time residents serving as a knowledgeable panel for the study, identified nearly 90% of Township families with older members who lived in the Township in the past 10 years. Copies of the study report went to the Town Board and Planning Commission as well as St Louis County Planning with whom the Committee is working.

The Committee is looking for suitable land for the project. An ideal would be 20-40 acres in a central or accessible area. If you have land that you would be interested in having used for this purpose, please contact Supervisor Wendy Anderson (525-0263)

If you have had problems getting or receiving email from our Town Hall, the problem is about to be solved. Over the past months the router provided for access to the high speed internet has been replaced several times and the Coop Light and Power's service person has been called but that hasn't helped. The Town Board decided to hire a different service organization to help get us connected. As you might suspect, internet connection is increasingly critical for our Township Police, Planning and Zoning and our Town Clerk as well as residents.

The new service organization is CW Technology. They also have personnel certified to work with police computers. Work will involve better security and backup, review and updating of computers and help in smoothing out our CLP high-speed internet connection. We hope and expect that you will be better served by this improvement.


Building Assessment Team (BAT)





What should be recycled?



Paper and Cardboard

- Press or pasteboard boxes and packaging (cereal and shoe boxes, packing and clothing inserts, legal pad backing etc.)
- Paper of any color
- Copy machine and uncoated fax machine paper
- Envelopes with or without windows or self-adhesive
- Tablets, legal pads, and notebook paper
- Junk mail
- Glossy pamphlets and brochures
- Manila folders and envelopes
- Newsletters
- Shredded paper
- Carbonless paper
- Paper ream wrappers
- Paper bags
- Phone books
- Newspapers
- Magazines
- Corrugated Cardboard


Plastic

- Check the bottom of your containers to make sure they are labeled #1-7
- Rinse all food containers
- No FILM or FOAM. This includes any Styrofoam, plastic bags or wrap
- No plastic cups, plates, or utensils
- No flower pots or trays
- No buckets 5 gallons or larger
- No plastic that contained motor oil, antifreeze, or other automotive fluids




Metal

- Rinse all food containers
- Labels do not need to be removed
- Cans do not have to be flattened
- Do not include any scrap metal or non-food cans like paint or solvent containers



Glass

- All colors of glass are accepted for recycling
- Rinse all food containers
- Labels do not need to be removed
- Do not include any window glass, canning jars, ceramics, dishes, or drinking glasses

Summary of Town Board Meetings

(Official minutes are available at the Town Hall and on our Township web site: www.duluthtownship.org).

April 12th meeting. Supervisors attending: Dan Tanner (chair), Wendy Anderson, Jeff Cook, Stephen Dahl, and Dave Mount. This was the annual reorganization meeting. Dan Tanner was elected Chair, Steve Dahl was elected Vice Chair. There were no concerns from the audience. Fire Chief Bob Engelson and Supervisor Dan Tanner will meet with Alden Supervisor Pat Eller to discuss the Alden Township fire contract. The claims list was approved for payment. Road and Bridge maintenance bids for 2007-2009 were opened. Three bids were received (Rodda Excavating, Hagglund Construction, and Eagle Lake Construction). Bids will be awarded April 30th.

Department Reports: **Fire:** 1 fire, 2 medical, 1 training burn. A \$160,000 grant request will be submitted to FEMA for a new tanker. A search for a suitable tanker continues. **Community Center:** Final documents for a grant to replace windows expected by April 30th. A \$1000 check from the Student Activity account was given for the recreation field. NSCS will renew its contract with Johnson Controls for 2 years. The Board approved Two Harbor students using the gym for 2hrs. BAT will hold a March 8th open house.

Legal: The road contract will be reviewed before the April 30th bid award meeting. **Town Hall:** a flow chart of Township administrative structure was approved. **Planning:** An informational meeting on revisions to the Zoning Ordinance will be on May 17th. Planning will hire its own secretary although the Planning Director and Assistant Director are hired by the Board. **Recycling:** New shed keepers were approved: Al Anderson, Marlis Livingston, and Kathy Peer.

The Board approved a Town web site policy and procedure. Updates are submitted to the Town Clerk or Newsletter Editor, backup copies will be maintained.

Liquor licenses for *Nokomis* and the new *Lighthouse on Homestead* restaurants were approved.

April 30th meeting. All Supervisors attended. Road and Bridge bids for 2007-2009 were discussed. Eagle Lake Construction was rejected because they didn't have enough qualifications. The **Rodda Construction** bid was accepted. Responsibilities of each Supervisor for 2007-2008 were decided (see list on page 3).

May 10th meeting. Declared **Robert Abrahamson Day** in honor of his service to our Township. Supervisors attending: Dan Tanner (chair), Wendy Anderson, Jeff Cook, Stephen Dahl and Dave Mount. A plaque was presented to Bob showing the Township's appreciation for all he has given the Township as a Town Supervisor, maintenance person and recycling shed keeper.

Minutes of the last meeting were approved and the agenda set. There were no audience concerns. There was a number of items of correspondence. Steve Dahl and Wendy Anderson will take care of ordering calcium chloride from St Louis County.

(May 10th minutes continued)

The Treasurer reported receipts of \$21,480.66, expenses of \$38,856.71 and an ending balance of \$613,171.87. The claims list was approved for payment.

Department Reports: **Police:** Events for April were listed. ATV's are tearing up roads with circle spins—a continuing problem. **Fire:** Bids will have to be sought for a fire tanker. Alden fire contract is being reviewed. Alden wants a lower price. **Road and Bridge:** Road contract with Rodda Construction will run from May 10th, 2007 to April 30, 2009. He was instructed to grade all Township roads. **Community Center:** Motion approved to include recreational fields in mowing agreement with NSCS, contingent on approval of NSCS Board. Widely announced BAT public information meeting had 21 people attending. **Legal:** School lease expires June 30th. Attorney Tim Strom was asked to develop needed paperwork to be signed by NSCS and the Town Board. There was a discussion of the 60-day rule and the PUD ordinance revision. **Town Hall:** Repair issues were discussed. **Planning:** Public Hearing was held on the Lampi conditional use permit for a dog kennel and permit was approved. On May 21 there will be a meeting with Stoney Point property owners and DNR on soil and water items. May 17 is Zoning information meeting and June 7th is the public hearing on Zoning Ordinance updating. **Cemetery:** Miller Creek Lawnmowing is working out well. Rock and dirt were ordered.

The Lakeview Castle liquor license was tabled until receipt of documentation.

They are pursuing permits for sewer connection, shoreline stabilization, etc. They asked for input from the Planning Commission so that concerns could be addressed. A site meeting was planned.

Attorney Strom made suggestions on the proposed PUD ordinance language.

Michael Kahl reported on the proposed LIU ordinance changes: no new zoning district, conditional uses, lot size, finalization on excavating.

The Comp Plan will be reviewed at next month's meeting, especially on wetland and wildlife issues.

New zoning maps arrived and will be posted.
