



In comparison to the year 2010, the following police related calls for service can be noted:

- Damage to Property calls dropped from 27 in 2010 to 8 in 2011.
- Animal Complaints rose from 38 in 2010 to 46 in 2011.
- Burglar Alarms rose from 34 in 2010 to 47 in 2011.
- Disturbance calls rose from 6 in 2010 to 14 in 2011.
- Medical Emergencies rose from 37 in 2010 to 50 in 2011.
- Personal Injury and Property Damage Accidents dropped from 2010 to 2011.
